We are in the process of revising procedures. Look for similar approach as used before for selecting presidential appointees.

Thank you to all who participated in Waves of Welcome - 16,408 students participated, some in multiple events. Over 2,000 students at Beach Bash. Very effective in increasing student engagement.

Thanks for support of TUF, got our numbers in from last year – need 51 PhD students to graduate this academic year to make it (100 in pipeline that could potentially graduate). We are excited about increased research, also want to maintain teaching excellence. Will be reaching out for teaching development and support to be sure that excellence continues. May be some resources that come from system for research.

Happy to have hosted P&T dinner last night to celebrate that important milestone.

11,365 students; have already done drops. This is a more accurate number to mirror what we will see at the end of year. Had a big graduating class last year. Total undergrad increased 9.6% since covid. Decrease in grad students: MBA stabilizing although still decreased, biggest decrease in international students (213). Most continuing students stayed with up. SCH up by 4.5%.

Speaker's Report

Timothy Scott Johnson, Speaker, TAMU-CC FAC

First and foremost, I am happy to note that the changes to our Constitution passed with over 90% approval among the voting faculty. 293 faculty members voted on the changes. This represents approximately 1/3 of all faculty on campus, including tenure track, non-tenure track, and adjunct faculty. Thank you to everyone's hard work, especially the members of the executive committee for helping me with this process during the summer. And thank you to our administration for their support throughout this process. Our revised constitution is now available on the FAC website. If you have older versions of the Senate website bookmarked, note that you will need to update your bookmarks. At some point since our last meeting, our website was migrated to a new URL that more accurately reflects our FAC name change. Links to the agendas of each meeting, minutes for previous meetings, and links to the livestream of meetings are available on the FAC website.

As regards streaming, this is our first use of the zoom webinar function. Thank you to CIO Ben Soto for helping arrange this. We'll see how it works. An alternative way to stream would be to send the live feed of our regular zoom meeting to a YouTube channel. Logistically, this would be much easier to set up for each meeting than the webinars. However, we will need to discuss this option with MARCOM if we choose to explore it, since a dedicated YouTube channel (and the required gmail account attached to it) would

need to be vetted by their office.

Since August, I have attended statewide meetings of representatives from the A&M System (in College Station and Austin) as well as the Texas Council of Faculty Senates (in Austin). Those meetings mostly focused on sharing knowledge about compliance with SB37. Relative to other schools in the system as well as other schools throughout the state, I am proud to report that we're ahead of the curve. Throughout all of these meetings, no one in A&M System has questioned our purpose or value. While at times it might seem like we're jumping through a lot of hoops, and believe me I feel that as well, my impression is that this is to ensure we can continue to operate and contribute to the mission of shared governance. Other topics discussed included the new telework legislation (SB 2615) and the revisions to the penal code (SB 412). Regarding the latter, the refrain from both system meetings and TCFS was that no one should change content of their courses if that content is valid and necessary for the course.

In Austin, system members addressed the question of course audits throughout the A&M System. As of now, there is no audit in progress. The System does plan to review courses, but the system first wants to set up clear guidelines and expectations for this review. No programs, departments, or colleges should be MacGuyvering their own reviews without this guidance.

Since our last meeting, I have fielded faculty concerns relating to 3 buckets:

- 1. Concerns over curriculum decisions
- 2. Ethical concerns over faculty decisions (in 3 different colleges)
- 3. New H1B visa requirements and the potential impact on students as well as faculty Recruitment

In outlining each of these, I am going to be deliberately circumspect, in part to give each party necessary cover should they not want the identifying details broadcast. Many of these concerns came to me through our anonymous Qualtrics survey link, so the information I have is limited by that initial anonymity. These three buckets likely are not exhaustive of all concerns.

Regarding bucket 1: These concerns are, I think, to some extent, predictable. One concern is the status of interdisciplinary programs, and which faculty have a controlling say over how and when that curriculum changes. The office of the provost is currently working on reviewing policies to address the issue. The other concern has to do with the types of assignments a specific program should or should not include in their courses. The program in question rightly asserts control over their curricular decisions. The underlying concern from administrators has to do with student success in the program's courses. I am trying to make sure that the program faculty are given the relevant data to have productive conversations with those administrators so that administrator concerns are accurately represented, and faculty are given the tools to address those concerns while maintaining control over their courses.

Related to the above, many colleagues reached out via the Qualtrics link to express their dismay at the guidance offered covering SB412, while one faculty member lauded the new legislation. It is my understanding that this is the only guidance we should expect from A&M System on this matter. Again, I would like to reiterate that faculty should not feel compelled to alter the content of their course materials if that content is necessary for properly teaching the course.

Bucket 2: In one college, there are concerns about standards for awards being clearly articulated to the faculty awards committee so that the purpose of the award aligns with the awardee and so that the process involved in

selection is transparent and clearly conveyed. I have relayed these concerns to the provost's office and hope that the college in question can review their policies to help the process in the future. In a different college, a faculty member has expressed their frustration over changes to the awarding of emeritus status for faculty. In particular, previously a now retired faculty member's emeritus status was voted down be by that retiree's peers. Under rules that appear to have been revised to this retiree's benefit, the emeritus application has been resubmitted and members considering this application are told that they cannot consider the factors that led to the retiree's initial denial of emeritus status. The following is taken verbatim from a Qualtrics submission: "Many colleagues expressed serious concerns and shared their experiences working with [the retired faculty member]. However, after that vote, the administration changed the rules so that emeritus status no longer requires faculty approval. This undermines shared governance and sidelines faculty voices. This round, the awards committee was instructed to evaluate solely on the contents of the candidate's packet, which by design excludes the testimony and concerns raised by faculty... The Texas A&M System's emeritus policy (Section 2, first paragraph) explicitly states that ethical conduct is a requirement for emeritus status... That minimization is unacceptable. Ethical conduct is not about whether someone has a "clean record" on paper; it also concerns the climate they create for students and colleagues." This is a very recent matter—the Qualtrics submission just appeared today—so I have not been able to have any discussion with administrators about this issue. However, any situation in which faculty are cut out of a decision is contrary to the spirit of shared governance. And any scenario where faculty members feel administrators are requiring them to ignore serious ethical concerns in their decision-making processes is contrary to TAMU System Policy.

In a third college, I received word there was a meeting where one senior faculty member made repeated sexist and misogynistic remarks directed at a colleague. The target of those remarks were then advised to *not* file official harassment complaints against the colleague. Whether a faculty member decides to file a complaint is of course their own decision. However, it is inappropriate for a supervisor to actively discourage a faculty member from making such a complaint. This is the sort of scenario where unacceptable behavior can thrive continuously without any formal documentation or redress. I would like to remind everyone that the system ethics point hotline is available should they feel there is a situation where these sorts of ethical issues are raised. If your peers in your units find themselves in a situation that they feel is ethically compromising, then please remind them of the ethics point resource.

Bucket 3: There is uncertainty about President Trump's recent executive order over \$100,00 fees associated with new H1B visa applications. Faculty have expressed concern about their own visa status (since there are many categories and stages involved in obtaining and maintaining visas) as well as concern over the university's ability to recruit and retain future faculty members.

Finally, the Provost's Office is currently reviewing the questions asked in the 360 evaluations of chairs, associate deans, and deans. In a subfolder in Teams (in this meeting's folder), I have uploaded the current text of those evaluations. If you have suggestions on alternative questions, wording, etc., please review those documents and send me your recommendations ahead of our next meeting in October. I will compile those suggestions and send them to the Provost.

Comment by John LaRue – system policy prohibits these violations and requires anyone that is aware to report it. John LaRue is available to speak to anyone.
