- 5. Speakers Report: Speaker Johnson SB37 Updates:

Our university current is in good position to keep our advisory body in place. We will cover much of the changes needed later in our action items. However, in brief I can say that at the system level, the existence of faculty bodies has not been under the same attacks that schools in the Texas State and UT Systems have seen. The biggest curveball is the regents' decision announced yesterday to change the name of Faculty Senates to Faculty Councils. This is something we will need to change in our Constitution when we get to our action items.

Appointed positions: Part of SB37 requires university presidents to appoint one representative from each electoral unit. President Miller asked existing senators to be forwarded to her for these initial appointments. These are the names we are asking President Miller to approve (she has been in College Station all week, so she has not had time to officially do this, but I don't think we have cause to worry here):

College of Science: Judy Metcalf
College of Liberal Arts: Miguel Moreno
College of Nursing: Cathy Harrel

Library: Lori Podolsky SAMC: Kevin Loffler COEHD: Ric Ricardo

College of Business: Joseph Mollick Engineering and Computer Science:

Alihan Hadimlioglu

The one exception to this list is Miguel Moreno. Since Mara Barbosa left the university, CLA had one senate seat vacant. We are asking President Miller to fill that vacancy with her appointment. Miguel, as many of you know, is a former speaker and capable senate representative.

When we cover the changes to the Constitution, our goal is to hold a vote here. If we reach that threshold, then in the next two weeks, we will host an open forum for the campus faculty community outlining these changes. Following that forum, we will then send out a vote to all faculty via Qualtrix asking faculty to vote the changes up or down. If 2/3 of respondents vote yes, then we will both be in good legal standing and abide by our original Constitution's guidelines for amendments.

Finally, you will notice some changes to our website. To make sure no one accuses us of not following SB37, I have asked Shay to take down our Constitution and Bylaws. We will upload the revised ones once they are ready. I have also asked her to draft a statement for our website that says beginning September 1, we are the Faculty Council. It will take some time to change the website more thoroughly.

A&M Faculty Senate Meeting, September 5-7, College Station:

I, Speaker Johnson, will attend. If there are specific questions you would like me to pose to other A&M system senators, please be in touch. I cannot guarantee any answers, but they might be able to provide useful perspectives based on practices at their institutions. SB2615 and remote work policies:

There is a new TAMU system policy, 33.06.01 Flexible Work Arrangements to comply with this new law. As of now, there is no TAMU-CC specific policy, but please keep your eyes peeled for one in the near future. It appears that those faculty and programs who work fully remotely should not be affected by any changes. The tricky parts will be negotiating people who work remotely part of the time.

Dual Credit Students and SB412 "Materials Harmful to Minors":

Revision to Texas Penal Code 43.24 that removes affirmative defenses for showing "materials harmful to minors" for educational purposes. This probably has an apparent narrow legal scope, but it opens the door to parent curricular challenges when you have an underage student in your classroom.

There are as of yet no System or campus policies here, but we should expect some changes in the future as we think about how to balance mitigating legal risks with keeping the content and integrity of our courses. I have already had conversations with Provost Rudowsky, Kevin Houlihan, and John LaRue about this.
