## II. Committee Reports

A. Curriculum Committee - The recommendations shared by Marvarene Oliver and listed below were approved as amended (see annotations).

- 2. Luis Cifuentes shared that the same funding estimate for Scholarships will apply for Graduate Assistants and that information would be disseminated the following week.
- 3. JoAnn Canales shared that the RGS was inviting all graduate students, as a complement to what was started in the ELITE program, to respond to an Academic Indicator email sent quickly. Data was being compiled on the nature of the responses and would be shared at a later date.
