Karen O'Connor-Urban knows firsthand the value of scholarships and financial aid. Urban began her education at the University of Pennsylvania. She completed her degree in dental hygiene at Columbia University and attained a master's degree with scholarship assistance, understandably recognizing the value of financial aid to complete an education. Her goal and the goal of each member of the Foundation is to provide scholarships to qualified students. Without scholarship assistance the University is not able to attract really great students and an outstanding faculty.

The challenge is that the University does not have the same alumni base as some older institutions, but that has not curtailed growth. The Foundation has assets of \$38.7 million dollars, up from \$36 million last year.

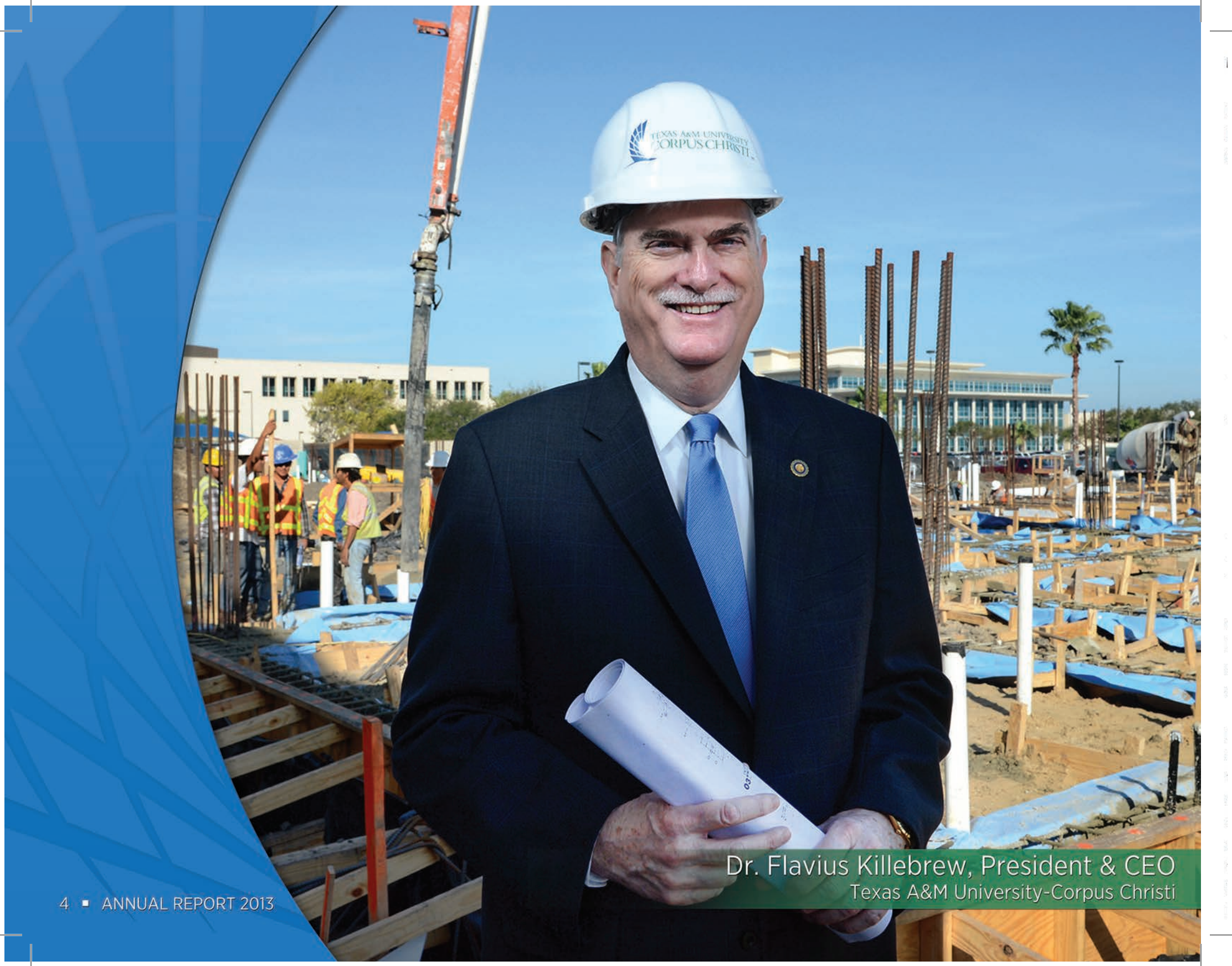
As the University and the Foundation continue to flourish there is important focus to increase the University's population of first-generation college students who might not otherwise have the opportunity to obtain an education.

Urban believes that one of the keys to generating excitement about the University is the importance of telling the school's story and nurturing community connections. Those connections and relationships are paramount when Corpus Christi recognizes that the University is one of the primary economic drivers for our city and surrounding area.

The Foundation Board is proud of the accomplishments of Texas A&M University-Corpus Christi and is eager to foster continued positive relationships with the campus and community.

The 2013 year proved to be one of incredible growth and innovation at the Island University as we continued to lead the university toward becoming an Emerging Research Institution. I am pleased to report that the Texas A&M-Corpus Christi Foundation has assets of \$38.7 million, up from \$36 million last year.

At A&M-Corpus Christi this year, funding from private donors and corporations has provided us with opportunities beyond imagination in our skies, on land, and underwater. Our labs are growing to include research on unmanned aerial vehicles, underwater rovers, genomics, and even dolphin respiration. It is through funding of endowed chairs and scholarships that we have been able to secure such unique research expertise on campus.

For example, Texas A&M University-Corpus Christi's Lone Star Unmanned Aircraft Systems Center is now the launch pad for the next era of aerospace development. As one of only six federally-designated test sites, the University's proposal beat 50 others around the nation to become the home of unmanned aerial technology.

To give our students in these demanding fields a top educational experience, we are forging ahead to increase research funding. The National Science Foundation has awarded us \$2.6 million in funding since March. In all, about \$3.4 million in grant funding has been awarded to our campus for the start of the 2014 fiscal year.

We are also competing with others around the state for \$3.5 million from the state's Emerging Technology Fund. This type of external funding allows us to attract faculty who are leaders in their fields to teach our students. Research programs on campus, like the Coastal and Marine System Science Ph.D. program that has been submitted for designation as a Center of Excellence, give students access to high-tech equipment and hands-on experiences that put them ahead of their counterparts at other institutions. The growth in research also gets the University closer to being classified as an Emerging Research Institution.

If we are awarded the designation, the University would be open to an even wider array of research opportunities that are bound to have a number of economic incentives for our community.

Our students are also getting an improved educational experience through new facilities, including the Dr. Jack Dugan Family Soccer & Track Stadium, two new residence halls, which opened last August, and two additional residence halls and a dining hall, slated to open next summer.

These upgrades are part of a larger plan to increase student engagement on campus and help students graduate and transition successfully into their careers.

As our student population nears 11,000, scholarship funding and gifts to our foundation that allow investment in our signature programs are becoming more crucial than ever. In the current fiscal year, the foundation has given more than \$1,257,500 to support academic programs and scholarships at the Island University.

With projections of the student population increasing to 22,000 by 2025, your partnership will be vital in keeping A&M-Corpus Christi a first-choice destination for students.

Dr. Blair Sterba-Boatwright, Professor/Donor
Texas A&M University-Corpus Christi

Dr. Blair Sterba-Boatwright's mother never got the chance to go to college. At the age of 13, she was forced to care for her own divorced mother during the Great Depression, before marrying and having children of her own, missing the ideal window for going to college. "It never occurred to her earlier," Sterba-Boatwright said. "She was too busy doing other things."

So when the 24-year veteran math professor's mother passed away last year, he said it was a natural progression to honor her by helping students who were primary caretakers for their families. He and his wife, local attorney Sandra Sterba-Boatwright, endowed a scholarship in honor of his late mother, Jean N. Boatwright. "My wife and I felt the obvious thing to do was to honor her in this way," Sterba-Boatwright said.

Sterba-Boatwright said of the 150 undergraduates he teaches each semester at least a half-dozen have come to him with concerns about time and financial constraints involved in balancing school and caring for their families. "You simply have to keep your eyes and ears open to how many students struggle to go to college and feed their families," Sterba-Boatwright said.



He hopes through this gift that several students can receive scholarships up to \$1,000 per academic year to allow them to work a few less hours, and have a few more hours for their families. Sterba-Boatwright made his scholarship endowment official with a small ceremony in November.

University President Dr. Flavius Killebrew said this scholarship will have a significant impact on students who are caring for family members.

"They will also know that

they are not alone in their journey to finance their education," Killebrew said at the ceremony.

“My parents were both very generous. In our family tradition, there is the feeling that education is the great leveler, a door opener to people who don't grow up with a lot.”

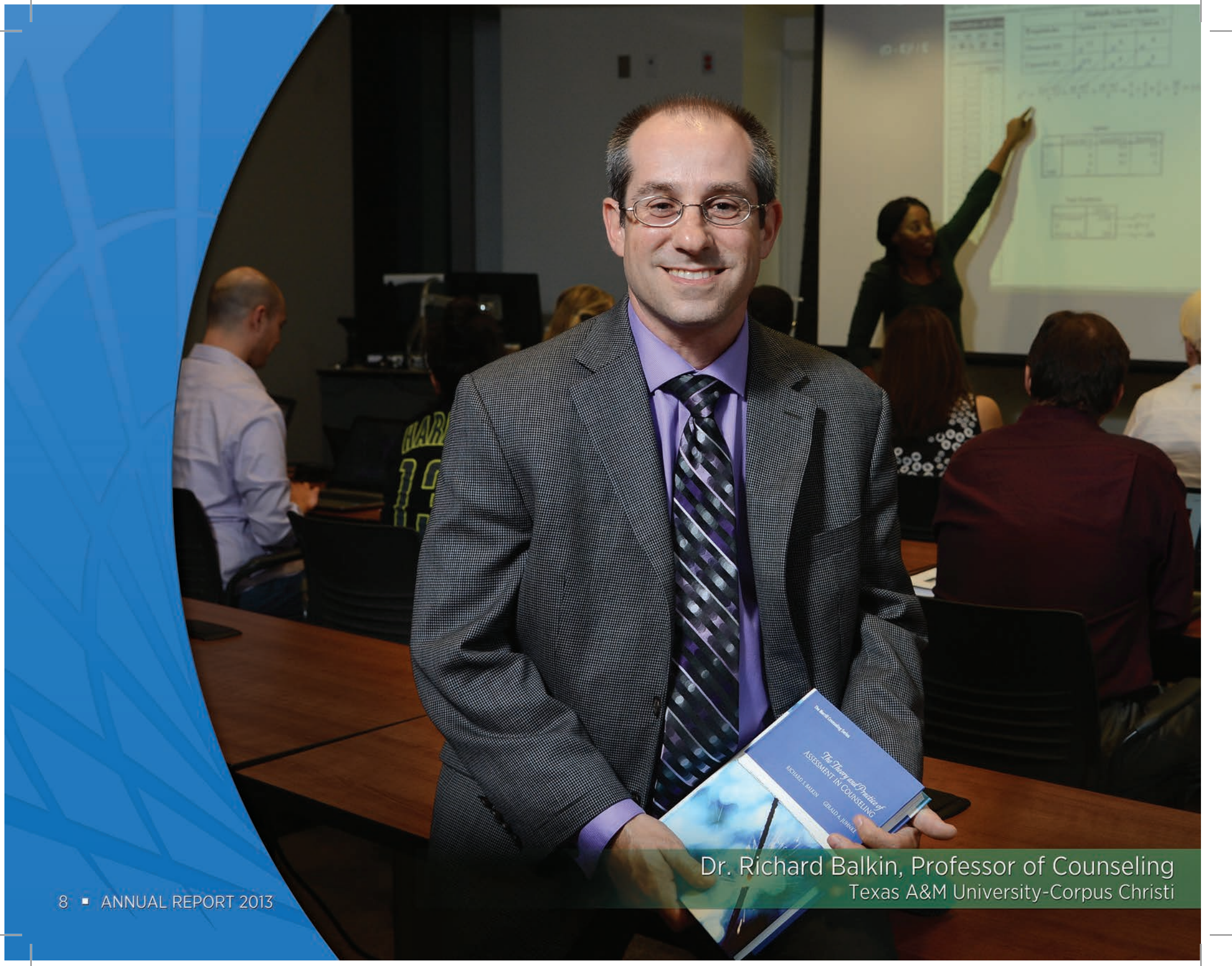
The family has endowed two scholarships at the University in the last decade. The first, endowed when Sterba-Boatwright's father died in 2000, was actually his mother's idea.

According to Sterba-Boatwright, his father worked hard to go to school during the Depression, and was always very generous to higher education as he became successful in the business world. He added that when the John W. Boatwright Memorial Scholarship was endowed, one of the considerations of giving to Texas A&M University-Corpus Christi was that, in the absence of a large endowment, they could make a bigger impact.

According to Sterba-Boatwright, in his 24 years at the University, he has witnessed a shift in the University's population. In all, he said, the population is younger, and more ethnically diverse. A larger population of first-generation college students has led to a larger population of students balancing multiple roles.

Senior Faith Mabo attended the scholarship reception in November, speaking of her own experiences balancing family and nursing school. Originally from Cameroon, Mabo's family moved to the United States after her mother passed away when she was only two. Mabo now helps her dad with her five siblings, balancing clinicals, school, and homework. "It's been difficult trying to manage school," Mabo said. "With scholarships, I am able to work less and focus on my education."

"I can only hope it does help students," Sterba-Boatwright said, "and take some of the stress off of them."



Dr. Richard Balkin, Professor of Counseling
Texas A&M University-Corpus Christi

If it weren't for his professors, Dr. Richard Balkin might not have reached his full potential. But the support of his professors led him in a different direction, one that would ultimately fuel a lifetime of research and allow the graduate students in the College of Education at the Island University experiences that would be impossible otherwise.

“When I engage students in research, it's an opportunity for them to do state and national presentations and get published. They get the full experience.”

As he finished his undergraduate coursework at The University of Missouri at Columbia, Balkin, now the Assistant Dean of the College of Education, was preparing to teach high school. Yet after a semester of work in the classroom, he felt a calling toward counseling. His professors affirmed his passion. “I got into counseling because I got good advice,” Balkin said. “I was encouraged toward mental health counseling.”

Balkin earned his Master's in Counseling Psychology and worked briefly at an alternative school, before working seven years with the Baptist Health Behavioral Services in Little Rock. It was here that he developed research interests that would lead him to earn his Doctorate in Counselor Education, and ultimately make a difference in South Texas by working with graduate students at the Island University and at-risk youth at the Antonio E. Garcia Arts and Education Center. “Two diverse areas of research emanated from this experience I had working in this hospital system with at-risk youth,” Balkin said.

The first area is related to therapeutic goal attainment for adolescents in crisis. Balkin studied and created an instrument to measure outcomes of counseling as patients worked toward mental health stabilization. Balkin's Goal Attainment Scale to Stabilization enabled hospitals to better negotiate treatment on behalf of patients to ensure they met all four areas of emphasis in his instrument – far beyond merely committing to safety.

It was after Balkin's move to Texas that the second area of research began. Balkin, who was working at Texas A&M University–Commerce at the time, was sitting in temple on Yom Kippur when the Rabbi was speaking about the Jewish concept of forgiveness. Balkin said he began to think of cases in which offenders couldn't

make restitution, yet forgiveness was still possible. He began to wonder about paths toward forgiveness, some of which did not feature a continued relationship between the parties involved. This would be the impetus for research that would lead to the Forgiveness Reconciliation Inventory (FRI).

Balkin has worked over a decade publishing in these two areas, along with other topics in counseling practices, spirituality, and at-risk youth. He won a Best Practice Award for his research on juvenile recidivism from the American Counseling Association in 2012. As Editor of the *Journal of Counseling and Development*, Balkin said he always pushes his students toward research.

He notes that almost all the research he's done at the University is collaborative. A doctoral student worked with him on the FRI, and it will be that student's first publication. “I want students to understand what they do and why they do it,” Balkin said. “I try to get students to experience conducting research and have appreciation for it, and move the field forward.”



Balkin teaches one class of master's and doctoral level courses each semester, balancing the remainder of his time with administrative duties for the school and assisting his students with research. He's very involved with getting his students into the profession, taking them to conferences and presentations.

“A lot of the students are first-generation graduates, not only are they college graduates – they went on to get master's or doctorate. When you help facilitate that, play a role in that, you have a part in a generational shift,” Balkin said.



Brianna Eby, Student
Texas A&M University-Corpus Christi

Brianna Eby reads her textbooks cover to cover even when it's not assigned. The 20-year-old senior kinesiology major is just that passionate about what she studies. "I love learning how the body works," Eby said. "It's so intricate."

Eby, who was the 2011 valedictorian of Moody High School in Moody, Texas, admits she's on the fast track to her ultimate goal of becoming a physical therapist. She earned a full ride to McLennan Community College in Waco, where she earned her Associate's in General Academics in 2012. She started Texas A&M University-Corpus Christi in Fall 2012, and is slated to graduate in December 2014. "I take all the minimesters," Eby said. "Summer, Winter, I do everything."

The seeds for her passion were planted when she was about four years old, when her father suffered a terrible accident. He fell off a ladder, and a garage door then fell on top of him. He had surgery for his injuries, but never fully recovered. "It really upset me," Eby said. "He was one of those obstinate persons who didn't want to go to physical therapy."

As the middle child of three children, Eby watched the accident's effects on her siblings. Her older sister studied to be a physical therapist. Eby spent a week after graduating high school shadowing her sister's coworkers at Ethicus Hospital in Grapevine, and there her experiences ignited the passion that was started so long before. She saw a man who had been in rehabilitation take his first steps. After that, she said, she knew her life's calling. "By the end of the week I knew," she said. "What better job than to give someone their life back. I went in looking for a career and came out with my passion."



Those experiences, combined with the challenges Eby's brother has suffering from spondylolysis, have shaped her goals and day-to-day life. She is driven. Her days are full.

She takes 13 hours per week of classes, and has her disciplined daily routine with classes, working out, studying, and work. Eby works about 16-17 hours per week at Humpal Physical therapy as a gym and treatment technician. "I love it – don't consider it a job at all," Eby said. "We have so much fun. The patients are amazing. I learn so much from the patients alone."

“My mom works at Walmart. My dad at a warehouse. I didn't want to put that burden on them. I thank God so much and the people at the Foundation because without them I wouldn't be here. I wouldn't be able to make a difference without them.”

Eby runs and lifts weights each day. She calls it her daily medicine. She holds down her 4.0 GPA while remaining involved with BSM (Baptist Student Ministries), Golden Key International Honour Society, the Kinesiology Club, and Phi Theta Kappa. Even her weekends are filled with structure. On Sundays, she attends Windsor Baptist Church and delivers sack lunches to the homeless, before again hitting the books from 1 p.m. until about midnight. "I do everything with all my heart, mind and soul to glorify God," Eby said. "God gave me the ability to work with people. I owe it all to Him."

She's got her eyes looking ahead, to her internship next Fall, and ultimately to her doctoral program at Texas State University at San Marcos. But she's still well aware she's at Texas A&M University-Corpus Christi for a reason. "This is an amazing place," she said. "There's so much variety. A lot of professors have so much experience. All my professors are really happy."

Eby, like many students, relies on financial assistance to help her finance her education. She earned a Phi Theta Kappa scholarship upon admission and also received the Community Outreach Scholarship.

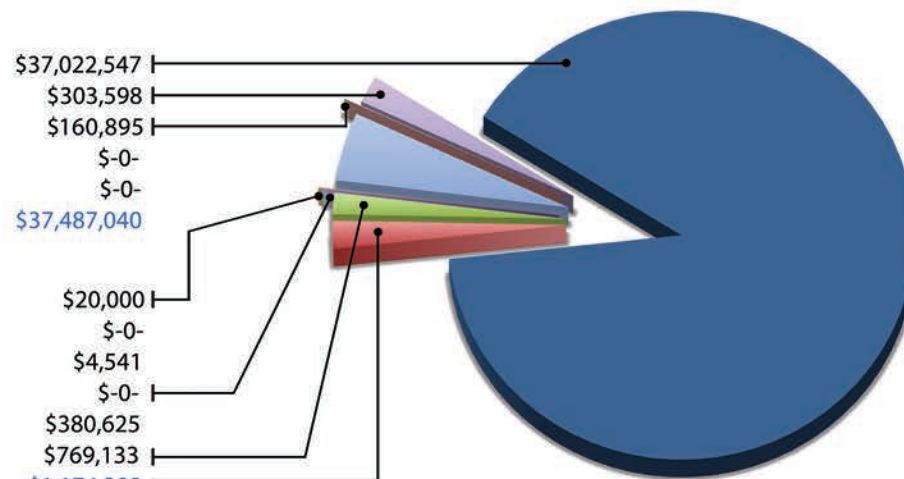

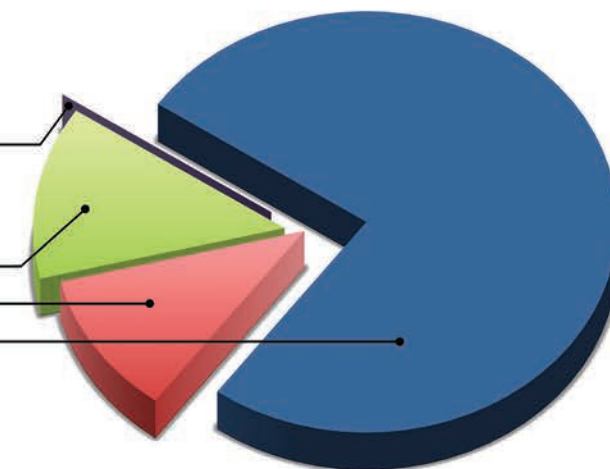

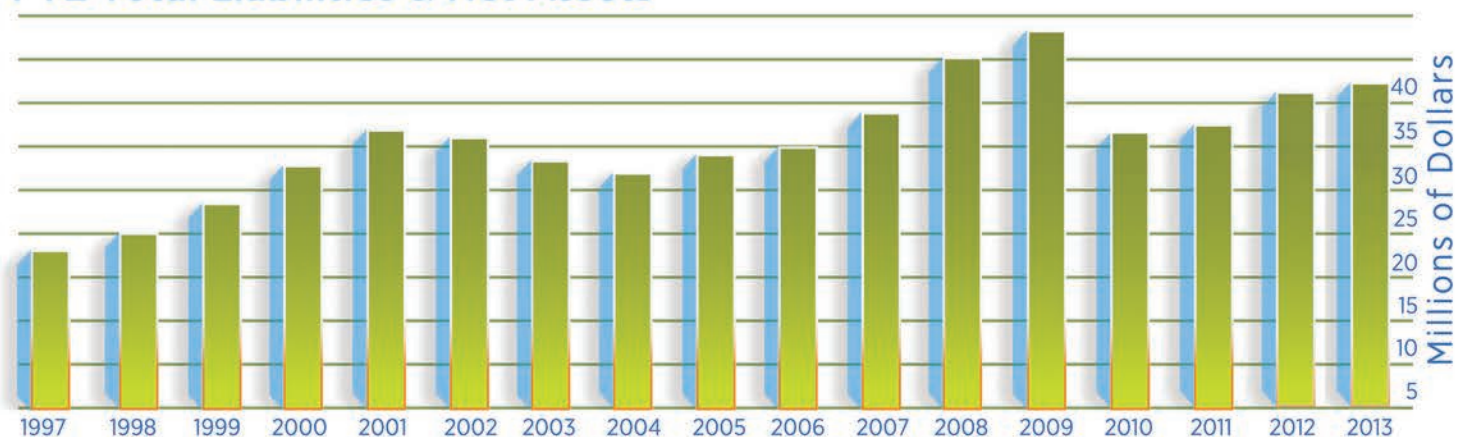
