1. Guest Speaker: *Ms. Jaclyn Mahlmann, Vice President for Finance and Administration, TAMUCC (15-minute presentation, 10-minute Q&A)*

- Ms. Mahlmann introduced herself and gave a presentation on IDC distribution for FY2019.
 - Presentation was emailed to Council.
- New IDC rates: FY2020 is 37%, FY2021 37.5%, and FY 2022 38.0%.
- She gave detail of IDC distribution by division/department. See presentation.
- Discussion and questions about opportunities for improvement on campus included: facilities, bursting pipes, building air conditioning issues, start up spaces for new faculty, Maestro, IDC rates, low IDC rate for state agencies.
