- 1. Jennifer introduced and welcomed the guest speaker Dr. Ramcharan.
- **2. Guest Speaker(s):** Dr. David Ramcharan, Associate Vice President and Chief Information Officer, Texas A&M University-Corpus Christi, (20-minute presentation, 10-minute Q/A).
 - 1. Dr. Ramcharan thanked CPIRA for inviting him. Topics discussed:
 - How are software adoption and software abandonment decisions made? Who is involved?
 - Probably reaching DLAI first, for researcher stuff they try to identify who the researcher is and reach out to them.
 - IT documents why they choose a software, look at the features, business value.
 - Moved from EndNote to Zotero because number of users went down. IT made the decision after talking to DLAI—DLAI has been recommending people to move to Zotero over the last year.
 - How can you prevent taking months to make a decision when you are trying to buy a software package?
 - IT is required to do certain things, to check for data loss prevention to check for accessibility concerns and things like that.
 - For faster software approval—ask vendor if they have VPAT for accessibility on ACR. If they have them, submit it with the request for software.
 - <u>Is there a way to help to pay for software licenses?</u>
 - If there is need to buy new software, ask IT—can negotiate better price on your behalf.
 - <u>Are there any reviews that you're doing right now? What's next with regard to software?</u>
 - Internally—Landesk, in process of retiring, and reviewing a new tool Sasa Press.

- Setting up an academic Governance Committee
 - Don't know how it will be structured—getting names from the Provost.
 - IT receives average of one software request per day: renewals and new software.
 - Come to consensus on which software to use? How to make the decision? It's up to the Deans and the program to say what software they need. The needs from the units can be different and IT as support team can make those decisions.
 - IT gets information requests, gathers that information and has the committee to look at it and make recommendations.
- On the website, the committee that decides the software that the university adopts doesn't have faculty representation.
 - That's changing. Those committees on the website are previous to the new committee structure. The website is not updated yet.
- Will those committees remain in addition to this one?
 - No. IT is changing some of the committee structure to allow good feedback and good communication.
- Canvas decision
 - Many faculty hadn't been informed until getting email from AA.
 - Decision was delayed—wanted to make sure everything was in place.
 - Would have been helpful communicating to the committee.
- Changes in the software in the research area should take long-term decisions into consideration.
 - Modeling done in SolidWorks but cannot open it now in new software.
 Affecting the progress of research.
 - Test to make sure that the reference file can be opened with the new tool.
- Is there a way to pull your files from EndNote into Zotero?
 - Lost access to your license; web license still available and you have all the data.
 - Announcement with info about how to transition from EndNote to Zotero, but have to do it on your own, it's not automatic from the university.
- This university has a distributed IT model.
 - IT doesn't own all the software, doesn't know number of licenses and who uses them.
 - If the unit owns the software, they paid for the training. It's not really an IT thing for the way it's structured today.

 - Have the infrastructure in place or meet the requirements for the infrastructure before you can even apply for the grant.
